2014 OBPC OREGON PRIMARY ELECTION ENDORSEMENTS

April 13, 2014

On April 11-13, 2014, the Oregon Black Political Convention (OBPC) met at the Crowne Plaza Portland Convention Center, 1441 NE 2nd Avenue, Portland, Oregon 97232, and endorsed federal, state and local candidates running for public office in the May 20, 2014 Oregon Primary Election. To receive the OBPC endorsement for the Primary Election, each candidate must receive three-fifth of the votes of the delegates eligible to vote during the endorsement process. The Convention tries to endorse the best major political party candidate for each partisan office. On April 12, 2014, candidates addressed the Convention. On April 13, 2012, the 2014 OBPC delegates endorsed the following partisan and non-partisan candidates. Two Republican Candidates met the requirement for endorsement by the 2014 OBPC.
